SEASONAL TOURER RULES - 2020 SEASON

In addition to the general Park Rules, please note the following rules that apply to the seasonal touring pitches:-

- 1. Please respect the privacy of other park users and please keep noise to a minimum, with absolute guiet between 11.00 pm and 8.00 am.
- 2. For your security, please ensure that your caravan is fitted with an anti theft device, e.g. wheel clamp, hitch lock, alarm, etc.
- 3. Awnings must fit on the gravel pitches, including extensions and not extend to the grass.
- 4. Please do not erect tarpaulins over the caravan or awning.
- 5. Windbreaks and gazebos may only be erected when the caravan is in use, they may not be left up permanently.
- 6. Please do not leave containers, gas cylinders, bicycles, mats, or other belongings outside your caravan or awning when the caravan is not in use, for visual and security reasons.
- 7. The caravan exterior should be cleaned periodically during the season, or at the Managers' request, in order to protect the visual amenity of the park.
- 8. While we take every care when mowing around pitches, please do not leave garden ornaments vulnerable to our strimmer, as we do not take responsibility.
- 9. To reserve your pitch for the following season, a non-refundable deposit of £225.00 will need to be paid to Reception by 1st September 2020.
- 10. All pitches must be vacated by 1st October; a storage charge of £10.00 per night will apply thereafter on uncollected caravans.
- 11. Our standard Interest Charge of Bank Rate + 8% applies to all fees unpaid at 1st April.
- 12. If you vacate the Park prior to the end of the season, and if we are able to re-let the pitch, a refund of 50% of the re-let fee will be made.

USE OF ELECTRICAL APPLIANCES

- a. The Pitch Fee includes 200 units of electricity, thereafter all units are chargeable. The meter will be read occasionally by the Park Staff, to monitor usage.
- b. A £75.00 deposit is required to cover electrical consumption over 200 units and as a damage waiver for our equipment, additional deposits will be required of heavy users.
- Only the caravan's factory fitted heating appliances and portable gas heaters may be used.
- d. Use of portable electric heating appliances such as panel heaters, fan heaters, catalytic heaters, etc. are not permitted in either touring caravans or <u>awnings</u>.
- e. Only electric kettles made specifically for use in touring caravans should be used, not domestic kettles from home. Caravan kettles are rated at around 750 W, whereas domestic kettles are usually rated at 2 KW.
- f. Only low wattage electrical items may be used in awnings, eg lighting, music centre, toaster, microwave, etc. No electric cooker, fridge, fridge freezer, washing machine, tumble dryer, etc.
- g. The Park will not be held responsible for failure of electricity supply due to the overloading of our circuitry by users of seasonal touring caravans.
- h. Our equipment is perfectly capable of coping with electrical demands of electrical appliances manufactured for the specific use in touring caravans. It is not designed to supply ancillary domestic equipment.
